**DETAILS:**

On August 27, 2010, at approximately 2322 hours, LVMPD Traffic Officer M. Polion, P#9800, was southbound on Las Vegas Boulevard just north of Fashion Show Drive when he pulled along the passenger side of a 2009 Cadillac Escalade bearing Nevada license plate LVJX84 and could smell the strong odor of marijuana coming from the vehicle.

When Officer M. Polion looked over, the female passenger started to put the window of the vehicle up. Officer M. Polion told the driver of the Cadillac, later identified as Cy Waits, date of birth 10/02/75, to pull his vehicle over. The vehicle then made a U-Turn at Fashion Show Drive pulling along the northbound curb in front of the Wynn Hotel located at 3131 South Las Vegas Boulevard. When Officer M. Polion contacted the driver of the vehicle, he immediately recognized the passenger of the vehicle as being Paris Hilton.

Since the vehicle was parked along the northbound curb of Las Vegas Boulevard, a large gathering began to take place. Officer M. Polion asked that a supervisor be en route to his

location, and I arrived soon after. Officer M. Polion had Waits exit the vehicle, and he administered a series of field sobriety tests, which Waits failed. Officer M. Polion said he was going to arrest Waits, and due to the strong odor of marijuana coming from the vehicle, when he first encountered it, he did not feel comfortable releasing the vehicle to the passenger in the car, Paris Hilton, as well as the fact he was still conducting his investigation.

As I was talking to Officer M. Polion, I saw a crowd of approximately 100 citizens crowding around the passenger side of the Cadillac after realizing Paris Hilton was inside the vehicle. This began causing a safety concern for not only the citizens on the side walk but to passing motorists, who were slowing to see what the commotion was. I was fearful that people could fall into the roadway and be injured. They also did not listen to several of my verbal commands to back up.

I approached the passenger side of the vehicle and told Hilton that she would need to exit the vehicle, as I believed that Officer M. Polion was going to search it for the narcotics he had smelled. Hilton told me that she was extremely embarrassed, due to all the people taking pictures of her, and she did not want to be seen by them. She stated that she wanted to stay to see what was going to happen to her boyfriend (Cy Waits), but she needed to use the bathroom badly and asked if I would accompany her inside the Wynn Hotel, which we were stopped in front of, to prevent her from being molested by the growing crowd and also asked to go somewhere private and out of the public's eye until the investigation was over.

I told Officer M. Polion I was going to walk inside the Wynn Hotel with Hilton, at her request, and that she needed to use the restroom, but she wanted to wait to see what was going to happen to her boyfriend. I also requested a female officer be en route to the Wynn Hotel, so she could accompany Hilton, as the crowd began to grow even larger. I also believed that Officer M. Polion was going to search the vehicle, due to his smelling the odor of marijuana coming from the vehicle, and Hilton could be a suspect if any drugs were found inside.

I met a Wynn Hotel security officer near the front of the hotel and explained to him that Hilton wanted to use the restroom and also go somewhere private. He said he could take us to the Wynn Hotel security holding room, which he said had a restroom nearby, and Hilton agreed to it. Hilton's request to go inside the Wynn Hotel and to somewhere private was also beneficial to the investigation, as I believed that Officer M. Polion was going to be searching the vehicle for narcotics after smelling the odor of marijuana coming from the vehicle, and Hilton could also become a suspect.

I went into the Wynn Hotel security holding room with Hilton, and she was carrying a purse and a few other small items. I had her place her purse on the table while we were waiting for the female officer to arrive to take her to the restroom. While we were waiting for the female officer to arrive, Hilton said she needed to put some lip balm on, and I handed her the purse from the table. As she began to open it, I saw a small bundle of what I believed to be cocaine in a clear baggy begin to fall from the purse and into my hand. I then immediately took the purse and dropped the bundle back on the top (waiting for another officer to witness the recovery).

Female Officer R. Reyes, P#13722, arrived soon after along with Sergeant J. Oaks, P#3920. In their presence, I then reopened the purse and removed the suspected bundle of cocaine. I then read Hilton her Miranda rights from a LVMPD, Miranda rights card. After I read Hilton her Miranda rights, she told me the purse was not hers, and that she had borrowed it from a friend. Also inside the purse was a broken tablet of Albuterol. Hilton admitted the Albuterol, which was found near the suspected cocaine, was hers and is prescribed to her, but the suspected cocaine was not.

She also said several cosmetic items inside the purse were not hers, but the \$1,300 cash and the credit cards were hers. I asked Hilton whose cocaine it was, and she said she had not seen it but now thought it was gum. Due to the fact that the suspected cocaine fell from the purse Hilton was carrying, that the suspect cocaine was found near a broken prescription pill that Hilton admitted was hers, that she admitted that other items inside the purse were hers (including a package of Zig Zag wrappers, which are commonly used to roll and smoke marijuana), and that she was the passenger inside the vehicle, which was stopped after Officer M. Polion smelled the strong odor of marijuana coming from it, I placed Hilton under arrest for possession of a controlled substance cocaine.

Hilton was transported to Clark County Detention Center by Officer R. Reyes, P#13722, and Officer C. Wandick, P#9174. While at the Clark County Detention Center, I tested the suspected, powder cocaine, which had a total gross weight of .8 grams. I was certified to conduct the ODV test and am also an instructor for ODV testing.

After performing the test, I received a positive test result indicating it was in fact cocaine. This test was witnessed by Officer M. Polion. I impounded the cocaine at Convention Center Area Command under event number 100827-4361, and Hilton was booked into the Clark County Detention Center for the above-listed charges.
